**Project Name:** Community Center- Brady Fisher

The City of Safety Harbor and Public Art committee request proposals from artists or artist teams to create a sports themed free-standing art piece.

**Project Goals:** The free-standing piece will honor the commitment by long time late downtown business owner and resident Brady Fisher. The piece should include a theme of sports. Mr. Fisher was a longtime supporter of youth athletic programs more specifically basketball. It should also include #BradyStrong on the piece (this is the # that the city embraced during Mr. Fishers battle with cancer).



**Deadline:** June 28, 2019

**Total Project Budget and Terms:** up to \$10,000

Fee includes: design/engineering, production, artists fees, materials, delivery, travel expenses, site prep, equipment, installation and insurance.

The City will provide concrete tubes or foundation for support if necessary. If unusual foundation is needed, then the cost must be accounted for within the budget.

**Selected artist must provide the following insurance coverage, unless mutually agreed upon:**

- Workers Compensation and Employer’s Liability Insurance with \$300,000 per occurrence
- General Liability Insurance with \$1,000,000 per occurrence
- Automobile Liability Insurance with limits of \$500,000 coverage for owned, non-owned, and hired vehicles
- The City of Safety Harbor should be named additionally insured on all policies

**Eligibility:** This project is open to all artists and artist teams over the age of 18 residing in the United States of America

The Community Center is a hub of recreational activity for all ages. Visitors to the Community Center enjoy basketball, fitness classes, pickleball, summer camps, afterschool programs, and private parties.

**Site Description:** The space is an entryway to the Safety Harbor Community Center. The area is being developed and will include paver base surrounded by a newly added seating area with benches. Space for the free-standing piece is 7'x7'. The piece should sit in the center of the space and not be taller than 12'.



**Media:** All proposed works must be of a scale and material suitable for outdoor display. Works must be designed to withstand the elements as well as interaction with pedestrians and the public.

**Selection Criteria:**

- Compatibility with the site, design, theme and function of the space.
- Highly durable, safe, low maintenance artwork preserved to withstand the natural elements.
- Artistic excellence, innovation, creativity and originality as demonstrated by submitted materials.
- Appropriateness and relevance of style.
- Cleaning and maintenance plan included in proposal.

**Application Process:** Submit the following materials by **Friday June 28, 2019 4:00 PM (EST)**.

- 1-10 images of artwork
- List of professional references – max 1 page
- Installation method
- Maintenance plan
