

**RESOLUTION NO. 2021 - 13**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021 BY APPROPRIATING REVENUES, EXPENDITURES AND FUND RESERVES WITHIN THE GENERAL FUND AND CAPITAL PROJECTS FUND TO PURCHASE A REPLACEMENT FIRE ENGINE AND ANCILLARY EQUIPMENT AT A DISCOUNTED COST; PROVIDING FOR PUBLICATION; AND PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the City Commission at any time within a fiscal year or within 60 days following the end of the fiscal year, may amend the budget for that year by resolution; and

WHEREAS, having observed all appropriate procedures required by Florida Statutes, the City Commission deems it necessary, proper, and in the best interest of the public to amend said budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED, that:



Section 3. This Resolution shall become effective immediately upon its passage and adoption.


