

RESOLUTION NO. 2018 - 23

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018 BY APPROPRIATING EXPENDITURES OF \$170,000 WITHIN THE GENERAL FUND FOR TRANSFERS FOR LAND ACQUISITION DEPOSITS AND DECREASING CORRESPONDING FUND RESERVES; BY APPROPRIATING REVENUES AND EXPENDITURES OF \$155,000 WITHIN THE CAPITAL PROJECTS FUND FOR LAND PURCHASES ESCROW AND PRE-CLOSING EXPENDITURES; AND BY APPROPRIATING REVENUES AND EXPENDITURES OF \$15,000 WITHIN THE PARKLAND FUND FOR LAND PURCHASE ESCROW AND PRE-CLOSING EXPENDITURES; PROVIDING FOR PUBLICATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission at any time within a fiscal year or within 60 days following the end of the fiscal year, may amend the budget for that year by resolution; and

WHEREAS, having observed all appropriate procedures required by Florida Statutes, the City Commission deems it necessary, proper, and in the best interest of the public to amend said budget.

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED, that:



Section 3. This Resolution shall become effective immediately upon its passage and adoption.






