RESOLUTION NO. 2019 - 11

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019 BY APPROPRIATING EXPENDITURES AND FUND RESERVE WITHIN THE GENERAL FUND FOR WATER UTILITY SERVICES ON MAIN STREET, EXPENDITURES AND FUND RESERVE IN THE WATER AND SEWER FUND FOR THE CITY'S PORTION OF 2018 EXPENDITURES AT THE NORTHEAST TREATMENT PLANT, AND APPROPRIATIONS AND FUND RESERVE IN THE SANITATION FUND FOR PURCHASE OF A SIDE LOADER VEHICLE; PROVIDING FOR PUBLICATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission at any time within a fiscal year or within 60 days following the end of the fiscal year, may amend the budget for that year by resolution; and

WHEREAS, having observed all appropriate procedures required by Florida Statutes, the City Commission deems it necessary, proper, and in the best interest of the public to amend said budget.

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED, that:




