



# Adopt-A-Street



## *Building Community One Street at a Time*

The Safety Harbor City Commission created the Adopt-A-Street Program on June 21, 1993. This program encourages clubs, organizations, businesses, civic groups and individuals to volunteer to remove litter along roadways within our city limits. The program is meant to increase civic pride in the City and continue to beautify the City's roadways. The Adopt-A-Street program is also vital to removing trash and debris before they become pollutants within the City's stormwater system.

### GETTING STARTED

- Complete and return the Adopt-A-Street Agreement.
- Two (2) representatives from your organization must meet a Public Works for a safety briefing and to pick up the safety supplies.

### TO PARTICIPATE

- Commit to removing litter four (4) times per year.
- Select a street segment or roadway to clean.

### CITY PROVIDED

- Recognition Signage
- Safety Vests
- Trash Bags
- Trash Bag Removal
- Record Keeping Forms

### VOLUNTEER PROVIDED

- First Aid Supplies
- Cell Phones
- Transportation
- Sunscreen and Insect Repellent





# Adopt-A-Street

## *Program Procedures*

- Schedule Clean-Up Date with Public Works. Take into consideration weather, City Events, City Construction Projects, and planned road closures.
- Review Safety Rules and Guidelines.
- Schedule with Public Works to pick-up safety vests, bags, cones, and gloves.
- Perform your clean-up.
- Place your bags along the roadway for pick-up. Notify Public Works that clean-up has been completed and how many bags (and where they are placed) are ready for removal.
- Return equipment to Public Works upon final clean-up event.
- Fill out the clean-up report and send in to Public Works.

AGREEMENT  
ADOPT-A-STREET PROGRAM

The City of Safety Harbor (hereinafter, the City) and \_\_\_\_\_

Any individual participant not agreeing to or failing to sign the attached Release may not participate in the Adopt-A-Street Program. The civic organization is responsible for preventing participation in the Program of any individual who has not signed the attached Release. Signs bearing the group's name may be installed solely at the discretion of the City.
